IMPORT REQUIREMENT OF 'HASS' AVOCADO (*Persea americana*) FROM PERU INTO MALAYSIA

The Department of Agriculture, Malaysia presents its highest compliments to the National Agrarian Health Service-SENASA Peru.

2. I wish to inform you that the Department of Agriculture, Malaysia is in the process of finalization of the import requirements on 'Hass' Avocado from Peru. Based on our expert's report and recommendations from the VOC visit on 7-11th August 2023, we would like to inform you that importation of 'Hass' Avocado will be approved with systems approach requirements. Details of the proposed import requirement as in **Annex 1**.

3. At this moment, Malaysia only allows imports from the Production Place (PP) and Packing House (PH) owned by exporters listed in **Annex 2**. While for the PP and PH which intended to participate for this exportation of 'Hass' Avocado in this season in compliance with the phytosanitary requirements established by the Department of Agriculture, Malaysia but not listed in Annex 2, I would like to request for supplement information in writing the details of the updated list of certified PP and PH by SENASA Peru. The Production Place (PP) and Packing House (PH) name shall be clearly printed on each carton box. The import requirement will be enforced in 14 days of this letter if we don't receive any feedback from your side.

Consignment must be inspected and tested according to appropriate official procedures and certified free from soil, pests, diseases, weed seeds contaminants and regulated articles by National Plant Protection Organization (NPPO) of exporting country.</p> <p>5. Upon arrival at Malaysia entry points, the consignment is subjected to visual inspection, examination or analysis by Malaysian Quarantine and Inspection Services Department (MAQIS) inspector prior to import clearance.</p>
Additional Declaration	<p>NPPO must include this Additional Declaration in the PC:</p> <ul style="list-style-type: none"> i. The issuance of this PC is based on the Malaysia IP reference number: MAQxxxxxxxxxxxxx and/or treatment certificate number: xxxxxxxxxx ii. The 'Hass' Avocado fruits must be sourced from certified Production Place (PP) and Packing House (PH) with specific code registered with the NPPO of PERU: <ul style="list-style-type: none"> a) Code no. of Production Place (PP) : xxxxxxxxxxxxxxxx and, b) Code no. of Packing House (PH) : xxxxxxxxxxxxxxxx iii. Each box containing the fresh 'Hass' Avocado must be clearly labelled with specific code registered Production Place (PP) and Packing House (PH). iv. The 'Hass' Avocado fruits have been inspected and certified to be free from following pests: <ul style="list-style-type: none"> 1. Insects: <ul style="list-style-type: none"> - <i>Ceratitis capitata</i> (Mediterranean Fruit Fly)

	v. The 'Hass' Avocado fruits have been inspected and found to comply with the requirement of the hard-mature green condition.

Other Requirement	<p>1. MAQIS officer(s) will take sample base on symptoms / signs of infestation on the consignment at the point of entry. The sample will be sent to the Biosecurity Screening Unit Serdang, Selangor, Malaysia for screening of pests, diseases and regulated articles.</p> <p>2. If any pests, diseases and other regulated articles are present during the further screening process, Department of Agriculture (DOA) Malaysia reserves the right to suspend future importation, until the cause of the non-compliance is investigated, identified and rectified to the satisfaction of DOA Malaysia.</p> <p>3. All cost incurred during screening activities will be borne by the importer.</p> <p>4. All re-exported consignment must be accompanied by a PC from the country of origin and a re-export PC from the re-exporting country.</p>
